IMPORTANT

- Please read all the instructions in this notification carefully and ensure that you meet the eligibility criteria before filling out the online application form.
- Applicants are strongly advised to submit their online applications well before the closing date to avoid potential issues due to heavy website traffic.
- If an applicant does not have a valid personal email ID, one must be created before applying. This email ID must remain active throughout the engagement process.
- This is a Centralized Notification for the engagement of Act Apprentices under the Apprentices Act, 1961, being conducted by East Coast Railway. The Railway Recruitment Cell, ECoR/BBS has been designated as the nodal agency for receiving online applications.
- Applications must be submitted **online only** through the RRC/BBS website **www.rrcbbs.org.in**, wherein a link has been made available.
- The applicant's candidature will be considered solely on the basis of the information provided in the online application form. Candidates will be shortlisted strictly on the basis of academic merit and the order of preference of Unit–Department–Trade exercised in their application, and Document Verification (DV) will take place at the Headquarters of East Coast Railway. A candidate shall be considered for only one combination of Unit–Department–Trade based on academic merit and preference. Once selected against a higher preference, all lower preferences shall automatically be treated as cancelled and shall not be considered further.
- In the case of direct recruitment from the open market to Level-1 posts (Pay Scale: ₹18,000 – ₹56,900), candidates who have completed apprenticeship training (CCAA) in Railway establishments and hold a National Apprenticeship Certificate (NAC) will be given preference for up to **20%** of the vacancies, subject to fulfilment of the eligibility criteria prescribed by RRB/RRC.
- East Coast Railway invites **ONLINE** applications from interested candidates for engagement as Act Apprentices against **1599** slots, notified for training in designated trades under the Apprentices Act, 1961, at various Divisions and Workshops under the jurisdiction of East Coast Railway for the year 2026–27.

ELIGIBILITY CONDITIONS

Age Criteria (as on 15/09/2026 – Closing Date)

1. Age of Applicants should be **15 to 24** years as on the closing date specified in this notification (**Closing date 15.09.2026**).
2. **SC/ST Candidates:** Upper age limit relaxed by **5 years**.
3. **OBC Candidates:** Upper age limit relaxed by **3 years**.
4. **Persons with Disabilities (PwBD):** Upper age limit relaxed by **10 years**.

5. **Ex-Servicemen:** 10(Ten) additional year for Ex-Servicemen (Ex SM) to the extent of service rendered in Defense Forces plus 03(Three) years provided they have put in a minimum of 6 months service at a stretch, except those ex-servicemen will be considered against ExSM Quota, regardless of their community. If UR vacancies are not available the ExSM belonging to those particular communities whose vacancies are earmarked, will be considered against ExSM quota. This is applicable to an Ex-Serviceman applicant who applies for self, not applicable to their children.
6. **(a)** An Ex-Servicemen selected under the reservation quota will be placed in the appropriate category (UR/SC/ST/OBC) to which he belongs.
7. **(b)** Ex-Servicemen, their children, and the children of Armed Forces personnel shall be considered for apprenticeship engagement under the following categories:
 - Children of deceased or disabled Ex-Servicemen, including those killed or disabled during peacetime.
 - Children of Ex-Servicemen.
 - Children of serving Jawans.
 - Children of serving Officers.
 - Ex-Servicemen.

For children of Ex-Servicemen, the same age relaxation as per community will be applicable.

Note: Unfilled ESM vacancies would be made good from other candidates.

ESSENTIAL QUALIFICATIONS

Applicants must have already passed the prescribed educational qualification as on the date of issue of this notification, i.e. **21/08/2026**, as detailed below:

Educational Qualification:

Applicants must have passed **Matriculation (10th Class)** under the 10+2 examination system with a **minimum of 50% aggregate marks** from a recognized Board.

Technical Qualification:

Applicants must possess an **ITI certificate** in the relevant trade, **affiliated to NCVT/Academic certificate**, as per the Apprentice Act 1961.

Note:

1. **Applicants whose SSC or ITI results are awaited** as on the date of this notification **are not eligible** to apply.
2. **Applicants who have failed in ITI** should not apply. If any such applicant is inadvertently engaged, the apprenticeship will be **terminated immediately without any further notice**.
3. **Engineering graduates and diploma holders** are **not eligible** to apply under this notification, as they fall under a separate apprenticeship scheme.
4. For Medical Laboratory Technician(Pathology), the candidate must be 12th pass (under 10+2 system) with physics, Chemistry and Biology with minimum of 50% marks in both 10th & 12th. Copies of mark sheet & pass certificates of Class 10 and Class 12 (with Physics, Chemistry & Biology) must be uploaded for Medical Laboratory Technician(Pathology) post.
5. For Secretarial Assistant and Stenographer, the candidate must be obtained National Trade Certificate (NTC) approved by NCVT/SCVT.
6. For Computer Operator & Programming Assistant, the candidate must have Board base basic training in Information Technology Sector under centre of excellence scheme in repair and maintenance of hardware of computer and peripherals. Or Board base basic training in Information Technology Sector under centre of excellence scheme in repair and maintenance of hardware of computer networking. The candidate must be obtained National Trade Certificate (NTC) approved by NCVT/SCVT.

TRADE-WISE APPRENTICESHIP SLOTS

The trade-wise details of applicants to be engaged for training as Act Apprentices, including the category-wise reservation for SC/ST/OBC/EWS and provisions for PwBD/Ex-Servicemen, are provided in **Annexure 'A'**.

Note:

1. The number of training slots shown in this notification is provisional and liable to increase or decrease depending upon the actual needs of the Administration at the time of finalization of selection.
2. There will be a horizontal reservation to the extent of 4% for Persons with Benchmark Disabilities (PwBD) and 3% for Ex-Servicemen. These quota slots are included within the overall notified slots and are not to be treated as additional.
3. Applicants who wish to avail the benefit of reservation under the Ex-Servicemen or Armed Forces Personnel category, including children of Ex-Servicemen and children of Armed Forces Personnel, must upload the appropriate Discharge Certificate or Serving Certificate of their parent, as applicable, at the time of online application.
4. In case the prescribed number of **Scheduled Caste (SC)** candidates is not available, the SC-reserved slots shall be filled by **Scheduled Tribe (ST)** candidates, and vice versa. If SC/ST-reserved slots remain unfilled even after such interchange, they will be filled by **Unreserved (UR)** candidates. Likewise, any seats remaining unfilled under the **OBC** or **EWS** categories shall also be filled by Unreserved candidates.
5. Applicants who wish to avail the benefit of reservation under the SC/ST category must upload their Caste Certificate in the prescribed Central Government format, issued by the competent authority, as per **Annexure 'B'**, at the time of online application.
6. OBC applicants are required to upload an OBC Caste Certificate along with a Non-Creamy-Layer certificate valid for the current year **2026–2027**, in the prescribed Central Government format (as per **Annexure 'C'**), issued on or after **01/04/2026** by the competent authority. The certificate must clearly indicate the caste, date of issue, and bear the official seal of the issuing authority. Applicants must also mandatorily fill in and upload a Self-Declaration form regarding their current Non-Creamy-Layer status, as per **Annexure 'D'**.
7. **Reservation for Economically Weaker Sections (EWS)**

Candidates who are **not covered** under the reservation scheme for SC/ST/OBC-NCL and whose family has a gross annual income of less than **₹8.00 lakh (Rupees Eight Lakh only)** shall be identified as belonging to the Economically Weaker Sections (EWS) for the purpose of availing the benefit of reservation.

The gross annual income shall include income from all sources — salary, agriculture, business, profession, etc. — for the financial year preceding the year of application.

The benefit of EWS reservation can be availed **only upon submission of a valid Income and Asset Certificate** issued by a Competent Authority, in the prescribed format as per **Annexure 'E'**. Only certificates issued by one of the following authorities shall be accepted as valid proof of EWS status:

- District Magistrate / Additional District Magistrate / Collector / Deputy Commissioner / Additional Deputy Commissioner / First-Class Stipendiary Magistrate / Sub-Divisional Magistrate / Taluka Magistrate / Executive Magistrate / Extra Assistant Commissioner.
- Chief Presidency Magistrate / Additional Chief Presidency Magistrate / Presidency Magistrate.
- Revenue Officer not below the rank of Tehsildar.
- Sub-Divisional Officer of the area where the candidate and/or family normally resides.

Note: Candidates applying against vacancies reserved for the EWS category must possess a valid Income and Asset Certificate as on the closing date of registration of the application under this notification. Candidates claiming reservation under SC/ST/OBC-NCL/EWS who fail to submit the prescribed Community Certificate will not be considered under the respective reserved category. However, if they fulfil all the eligibility conditions prescribed for the General (Unreserved) category, their candidature will be treated as General (UR) only.

PAYMENT OF FEES

The application fee (non-refundable) is **₹100/-**.

1. **No fee** is required to be paid by **SC/ST/PwBD/Women** applicants.
2. The application fee must be paid online only, through the payment gateway integrated with the online application process, as detailed below:
 - Complete the online application form in all respects on the RRC/BBS website **www.rrcbbs.org.in**.
 - After ensuring the correctness of the particulars, applicants are required to pay the fee through the integrated payment gateway. No change/edit will be allowed thereafter.
 - Payment can be made using Debit Card / Credit Card / UPI / Internet Banking, etc. Transaction charges for online payment, if any, will be borne by the applicant.
 - Once payment is successfully done, applicants will be redirected to the RRC/BBS website to download the application form.
 - If the fee is deducted but the application cannot be downloaded due to loss of connectivity, click the "Verify Payment" button to reconfirm the status from the payment gateway.
 - If, after completing registration, the fee payment transaction is not successfully completed, log in again and make the online payment afresh.

MEDICAL FITNESS & PHYSICAL STANDARDS

1. Candidates who are shortlisted and called for Document Verification (DV) must submit a Medical Certificate in the prescribed format provided in **Annexure 'G'**. The Medical Certificate must be signed by a Government-authorized (Gazetted) doctor, not below the rank of Assistant Surgeon, from a Central or State Government Hospital.
2. For Differently-Abled Applicants / Persons with Benchmark Disabilities (PwBD), the maximum permissible level of disability has been specified category-wise and trade-wise, as detailed below:

TRAINING PERIOD & STIPEND

Training Period

Selected applicants shall undergo apprenticeship training as per extant rules.

Stipend

Selected candidates engaged as apprentices will be paid a stipend at the prescribed rate during the training period, as per the extant rules and directives issued by the Railway Board from time to time.

MODE OF SELECTION

1. The selection of eligible applicants for training under the Apprentices Act, 1961 will be based on a merit list. The merit list for each unit will be prepared solely on the basis of the percentage of marks obtained in Matriculation, subject to a minimum of 50% aggregate marks. **The final panel will be drawn based on the Matriculation marks of the eligible applicants.**
2. For the purpose of calculating the percentage of Matriculation marks, the marks obtained in all subjects will be reckoned, and not the marks of any single subject or group of subjects.
3. In the event of two or more applicants securing the same marks, preference will be given to the older candidate. If the dates of birth are also identical, the candidate who passed the Matriculation examination earlier will be given priority. **There will be no written test or viva.**
4. Applicants are not required to send any hard copies of applications, certificates, or documents to RRC/BBS by post. All relevant documents must be uploaded online only.

Calculation of Marks

For the percentage of SSC/Matriculation marks, the total of all subjects in the mark sheet shall be considered. The calculation must not be based on the 'best of five' approach but must include all subjects — optional, additional, and alternate. Applicants with a CGPA must convert it to actual marks and enter the equivalent percentage in the online application.

Note: Any discrepancy between the marks/CGPA entered in the online application and the corresponding entries in the original mark sheet or certificate, if detected during Document Verification, will lead to summary rejection of the candidature.

- a) The trade-wise and community-wise merit list will be prepared, and candidates will be called for DV by the Headquarters based on merit in the relevant trade.
- b) The final selection shall be subject to verification of original documents/testimonials and submission of a Medical Fitness Certificate, as prescribed in **Annexure 'F'**.
- c) Candidates on the standby list will be issued call letters only upon receipt of details regarding absentees, medically unfit, or rejected candidates from the merit list. Call letters will be issued strictly in order of merit.
- d) Applicants are advised to remain prepared to report for DV.

MODE OF APPLICATION

- 1. Applicants are required to apply online by visiting **www.rrcbbs.org.in**. Detailed instructions for filling out the online application will be available on the website.
- 2. Candidates must first register and then log in accordingly. A candidate is allowed to submit only one application; submission of more than one application shall summarily disqualify the candidate.
- 3. During submission of the online application, a Registration Number will be issued to each applicant and must be preserved and quoted at all further stages of the selection process. Candidates must not change their registered mobile number or email ID during the entire process. All important notifications will be published on the official website, and email/SMS communications will be sent only to selected applicants; such communications shall be deemed to have been read by the applicants.
- 4. Candidates are responsible for the correctness of the information filled in their online application. Any false information shall lead to immediate disqualification.
- 5. Candidates must take a printout of their online application after final submission for record. If found eligible, the candidate will be called for DV.
- 6. Applicants must fill in their personal details, trade, Aadhaar number, marks/CGPA, and choice of Division/Workshop very carefully, as the computerized merit list will be generated solely on the basis of the information provided. Any discrepancy found during Document Verification will result in summary disqualification.
- 7. Applicants must be in possession of an Aadhaar Card and must enter their 12-digit Aadhaar number at the time of registration. Those who have enrolled but not yet received the card may enter the 28-digit Aadhaar Enrolment ID printed on the enrolment slip. This provision applies to applicants from all States and Union Territories; the original Aadhaar Card must be produced at DV.
- 8. Applicants must ensure that their name, father's name, and date of birth exactly match the details recorded in their Matriculation or equivalent certificate. Any discrepancy found during DV may result in cancellation of candidature and debarment.
- 9. Applicants are permitted to choose only one Division/Workshop; the option once exercised shall be final and binding. Applicants are advised to refer carefully to the trade-wise vacancy table (**Annexure 'A'**) to ensure the Division/Workshop applied for has available vacancies corresponding to their trade, qualification, community, and category.
- 10. Applicants possessing ITI qualifications in more than one trade may apply separately for each relevant trade.
- 11. Applicants attempting to submit more than one application for the same trade using different particulars (name, father's name, community, PwBD status, qualifications, or different Email IDs/Mobile Numbers) are informed that all such applications will be summarily rejected.
- 12. Applicants must download and retain a printout of their online application, to be produced whenever requested by the Railway Administration.
- 13. Applicants must report for Document/Certificate Verification with their original documents, along with the Medical Fitness Certificate (**Annexure 'F'**), at Railway Recruitment Cell, Bhubaneswar.
- 14. Applicants claiming consideration under the EWS quota must upload their EWS Certificate as specified above (**Annexure 'E'**).

DOCUMENTS TO BE UPLOADED

Scanned Photograph / Soft Copy of Photograph

Candidates must upload their recent colour photograph as per the specifications on the website — clear front view, without cap or sunglasses. RRC may, at any stage, reject applications with an old/unclear photograph or where there is significant variation between the uploaded photograph and the candidate's actual appearance. Candidates should keep two additional copies of the same photograph ready for DV. The photograph (size 3.5 cm × 3.5 cm) must be taken not earlier than three months from the date of application, in JPG/JPEG format at 100 DPI, with file size between 20 KB and 70 KB.

Scanned Signature / Soft Copy of Signature

Candidates must upload their signature as per the specifications on the website. The scanned signature (size 3.5 cm × 3.5 cm) must be in JPG/JPEG format at 100 DPI, with file size between 20 KB and 30 KB.

List of Documents

Candidates are required to upload legible scanned copies of the following documents:

- Mark sheet and Pass Certificate of Matriculation (Class X) or its equivalent.
- Certificate as proof of date of birth, if not mentioned in the Matriculation certificate.
- Consolidated mark sheet for all ITI semesters of the relevant trade, OR Provisional National Trade Certificate indicating marks.
- National Trade Certificate issued by NCVT, or Provisional Trade Certificate issued by NCVT/SCVT.
- Caste Certificate for SC/ST/OBC candidates.
- Income and Asset Certificate for EWS candidates.
- Disability Certificate, in the case of PwBD candidates.
- Discharge Certificate / Serving Certificate, in the case of candidates applying against the Ex-Servicemen quota.
- Certificate for candidates seeking fee exemption, wherever applicable.

IMPORTANT: Candidates must produce the ORIGINALS of all the above documents during Document Verification. Certificates in languages other than English or Hindi must be accompanied by an attested English/Hindi translation.

Training & Stipend

- Apprentices will be paid a monthly stipend at the prescribed rate as per the extant rules.
- No hostel accommodation will be provided during training; apprentices must make their own arrangements. On completion of training, the apprentices will be released.

INVALID APPLICATIONS / REJECTIONS

Applicants must carefully fill in accurate details and upload all relevant documents. Applications found with the following shortcomings or discrepancies will be rejected at the time of Document Verification:

- Application without scanned signature.
- Application without scanned photograph.
- Application with a photograph in which the applicant is wearing goggles, a cap, wig, or coloured glasses, or where the photo is disfigured, too small, or unrecognizable.
- Non-possession of the prescribed Matriculation and ITI qualifications for the relevant trade as on the date of application submission.
- Absence of relevant certificates as proof for claiming age relaxation or fee relaxation, wherever applicable.
- Application without valid proof of age.

- Applications submitted by over-aged or under-aged applicants, and/or those with illegible, incorrect, or missing date-of-birth certificates.
- Incorrect / incomplete applications in any form, as and when detected.
- Multiple applications with minor changes of information or varied details for the same trade.
- Applications without the examination fee of ₹100/-, wherever applicable, or with less fee.
- Applications without the relevant legible Annexure.
- Any other form of irregularity observed and considered invalid by RRC/BBS.

AGREEMENT OF TRAINING

The entire training programme under the Apprentices Act, 1961 is governed by the provisions of the Apprenticeship Contract between the employer and the apprentice. The Apprenticeship Contract/Agreement must be submitted to the Apprenticeship Adviser for registration within three months from the date of signing.

1. Before the commencement of apprenticeship training in the designated trade, selected applicants must enter into a Contract of Apprenticeship as per the prescribed provisions.
2. If the Contract of Apprenticeship is terminated due to the employer's failure to comply with its terms and conditions, as notified under the Apprenticeship Rules, 1992, the employer shall be liable to pay the apprentice compensation equivalent to the apprentice's last drawn stipend for three months.
3. In the event of premature termination due to failure on the part of the apprentice to comply with the terms and conditions of the contract, the apprentice/surety shall be liable to pay such amount as determined by the Apprenticeship Adviser towards the cost of training — equivalent to the apprentice's last drawn stipend for three months — recoverable from the apprentice or, in the case of a minor, from the guardian.
4. As per the Apprentices Act, it is not obligatory on the part of the employer to offer employment to the apprentice after completion of training. Accordingly, apprentices trained in Railway establishments shall have no claim for employment in the Railways, nor shall it be obligatory on the apprentice to accept employment under the employer.
5. In case the selected applicant is a minor, the guardian must enter into the Contract of Apprenticeship with the employer.

TEST AND GRANT OF CERTIFICATE

Every Trade Apprentice, upon completion of training, will be granted a Certificate of Proficiency by the National Council, subject to passing a test conducted by the National Council for Training in Vocational Trades to assess proficiency in the designated trade.

IMPORTANT INSTRUCTIONS

1. The decision of the Railway Administration in all matters relating to eligibility, acceptance or rejection of applications, mode of selection, and allotment of Division/Workshop shall be final and binding.
2. No correspondence will be entertained regarding engagement or selection.
3. Canvassing in any form will result in disqualification of the candidature.
4. Applicants must ensure that they fulfil all eligibility conditions before applying. If found erroneously engaged at any stage, such applicants shall be summarily dismissed without notice.
5. The candidature of applicants will be cancelled if they fail to produce the required original documents for verification, or if any discrepancy is noticed.
6. If found ineligible or erroneously engaged, the apprenticeship shall be terminated without any prior notice at any stage.
7. The Railway Administration does not take responsibility for sending replies to applicants who are not selected or not called. No correspondence regarding the submitted application will be entertained.

8. The Railway Administration shall not be held responsible for any inadvertent or typographical errors.
9. No Daily Allowance (DA), Conveyance Allowance, or Travelling Allowance (TA) will be paid to applicants called for Document Verification.
10. After selection, requests for change of **Trade, Division, or Workshop** will not be entertained. Candidates will be posted only within the jurisdiction of the concerned Division/Workshop.
 - Applicants will be trained only in the trade for which they have been selected.
 - Applicants selected for training will not be permitted to withdraw, except for reasons beyond their control.
 - Those who wilfully remain absent from training shall be liable to refund the entire cost of training as well as the stipend paid, as determined by the Central Apprenticeship Adviser.

IMPORTANT ADVISORY

Applicants will be selected purely on the basis of merit. Railway Recruitment Cell, Bhubaneswar has not appointed any agents to act on its behalf. Applicants are cautioned not to fall prey to any such claims made by individuals or agencies.

IMPERSONATION / SUPPRESSION OF FACTS – WARNING

1. Any applicant found using unfair means during Document Verification — such as sending someone else in his/her place or attempting to impersonate — will be **disqualified** from the selection process.
2. Applicants who submit **forged or fake certificates/documents** to secure eligibility or obtain any benefit will face immediate rejection of their candidature.
3. Applicants are strictly advised not to bring in or attempt to bring in any political or other influence. The candidature of such individuals is liable to be cancelled without any prior notice.

LEGAL MATTERS

1. Any legal matter arising out of this Employment Notice shall fall under the exclusive jurisdiction of the **Central Administrative Tribunal (CAT), Cuttack**.
2. The online application process is a critical step and must be treated with utmost seriousness. Any attempt to manipulate the process by providing false information or engaging in misconduct — such as uploading obscene or objectionable content — will be dealt with severely, and such applicants will be liable for criminal prosecution in addition to administrative action.
3. Applicants are warned against touts and job racketeers who may attempt to deceive them with false promises of securing employment in the Railways. Do not fall into their trap.
